POSITION: TRANSIT DRIVER (ONE POSITION)

TYPE OF POSITION: **PART TIME**

HOURS OF WORK: VARIES BASED ON TRIP SCHEDULES

RATE OF PAY: **\$10.00 per hour**

DUTIES AND RESPONSIBILITIES:

Employee is responsible for the safe transportation of Human Service Agency clients and General Public clients to medical appointments, shopping locations, etc.

PHYSICAL REQUIREMENTS:

- Applicant must be in sound physical and mental condition.
- Must have vision in eyes, normal depth perception, and normal peripheral vision and be free of any disease or condition that could impair vision.
- Must have adequate hearing to assure safe response to horns, sirens, etc.
- Must not be addicted to the use of alcohol, narcotics or habit-forming drugs.
- Must have a doctor complete a physical exam 12 months prior to employment.
- Must be able to physically assist passengers in an evacuation from the bus or van.

AGE: **Applicants must be at least 21 years of age.**

LICENSING:

- **Must currently have a valid North Carolina Commercial Driver's License (CDL)**
- **Must have a P endorsement (passenger)**
- Must have a good driving record with no Driving Under the Influence, reckless driving, and railroad crossing violations, or leaving the scene of an accident.

MUST PASS A CRIMINAL RECORDS CHECK AND A DRUG/ALCOHOL SCREENING FOR A SAFETY SENSITIVE POSITION.

Must be able to work with the public; must be able to learn quickly the roads of Martin County and be able to read both local and state maps. Must be able to read all the posted traffic signs. Must be able to obey all traffic laws and safely operated a bus or van. Must be able to read, comprehend, and correctly apply safety policies and protocols.
